## 9. Watch Commander Keith Community Fire Station

Watch Commander Kevin Mitchell gave his report for October; there were 10 Fire calls, 4 False alarms, two RTC's one of which became a search and rescue operation in collaboration with the Coast Guard and Police Scotland. There was a kitchen fire in Keith, two False alarms with good intent (an alarm clock mistaken for a fire alarm and a smokey BBQ mistaken for a fire).

Watch Commander Mitchell also organised and hosted a multi agency Table Top exercise concerning a warehouse fire which was held at a Chivas Brothers.

## 10. AOCB:

KCC will make a donation to the Scottish Fire Service Benevolent Fund.

Chair Neil Kidd will represent Keith Community Council at the annual Remembrance Sunday service and lay the KCC wreath. D. Borland will deputise if Neil Kidd is unavailable.
